

TOWNSHIP BOARD OF TRUSTEES SPECIAL MEETING

July 24, 19

The Board of Trustees of Danbury Township, County of Ottawa, Ohio, met in special session at 6:00 p.m., on July 24, 2019 at the Danbury Township Hall, 5972 E. Port Clinton Eastern Road, Marblehead, Ohio 43440, with the following members present:

Ms. Dianne Rozak; Mr. John Paul Dress; Mr. David Hirt was excused. Also in attendance was Cole Steinbrick, Erin Steinbrick and Tom and Christine Steinbrick.

Hearing no objections:

Ms. Rozak introduced the following resolution and moved its adoption:

RESOLUTION NO. 10 - 2019

A RESOLUTION ADOPTING AN APPLICATION FOR A MAP AMENDMENT TO THE DANBURY TOWNSHIP ZONING MAP

WHEREAS, Ohio Revised Code section 519.12(A)(1) authorizes amendments to the zoning map initiated by the filing of an application by one or more of the owners or lessees of property within the area proposed to be changed, and

WHEREAS, Tom & Christine Steinbrick, Owner of Property, filed Case No. ZC-2019-080 requesting a Map Amendment from "A" Agricultural to "C-2" General Commercial for 2.57 acres (part of PIN# 0140838328384000, Sec. 4, Lot 14 Firelands Survey) located at 5910 E. Port Clinton Eastern Road; and

WHEREAS, the Ottawa County Regional Planning Commission held a public hearing on June 18, 2019, and recommended unanimous approval of the proposed map amendment; and

WHEREAS, the Danbury Township Zoning Commission held a public hearing on July 1, 2019 and by motion and vote recommended 5-0 approval of the proposed map amendment as presented, and

WHEREAS, on July 24, 2019 the Board of Trustees held a public hearing on said amendment, received public comment, and reviewed all pertinent documents, and

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees at the conclusion of the public hearing, by motion and vote, voted to accept the recommendation of the Danbury Township Zoning Commission and that the application for a Map Amendment be approved as presented, finding that the Decision Criteria "iii" of Section 7.6.7.B of the Danbury Township Zoning Resolution is satisfied and that the amendment would be in the best interest of the Township and the public, and is in keeping with good land use planning.

BE IT FURTHER RESOLVED by the Board of Trustees of Danbury Township, Ottawa County, Ohio:

- 1) The Board does hereby adopt the amendment to the Danbury Township Zoning Map attached hereto as Exhibit A; and
- 2) That the property be subject to the regulations of Article 3.1.8 ("C-2" General Commercial) and other applicable sections of the Danbury Township Zoning Resolution, including but not necessarily limited to area regulations, building setbacks, landscaping, buffering and screening, signage, lighting, and parking lot standards; and
- 3) That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were taken in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code; and
- 4) That this Resolution shall be effective at the earliest date allowed by law.
